The Board of Fire & Police Commissioners of the Town of Cicero is currently seeking applications to develop a Police Eligibility List. The list will be active for 2 years in accordance with the Rules and Regulations of the Fire and Police Commission.

**Application packages can be picked up at the Fire & Police Commission Office located at 5410 West 34<sup>th</sup> Street, Cicero, Illinois, on July 13<sup>th</sup> 14<sup>th</sup> 15<sup>th</sup> 16<sup>th</sup> and July 20<sup>th</sup> 21<sup>st</sup> 22<sup>nd</sup> and 23<sup>rd</sup> between the hours of 12:00 P.M. And 6:00 P.M. ONLY.**

A non-refundable processing fee of **\$50:00 (money order, or cashier's check)** Payable to the Town of Cicero is required upon receipt of the application package.

Application packages must be picked up and returned by the **Applicant ONLY**: A Photo I.D. Must be presented at the time of pick-up and upon returning the application package.

**REQUIRED QUALIFICATIONS:**

- \*Minimum age of **23** years and under 35 years by application pickup
- \*Maximum age of under 35 years at time of appointment
- \*Must be a United States Citizen
- \*Certificate or Copy of Naturalization Papers
- \*Copy of Social Security Card
- \*Copy of High School Diploma or Equivalent
- \*If you have served in the Military, you must provide a DD214 form
- \*Able to speak and write English
- \*Copy of Valid Illinois Driver's License
- \***Applicants must not have a criminal record**
- \*Qualified candidates will be required to pass the following tests:

Orientation, Written, Physical Agility, Oral Interview, Psychological, Polygraph, Background Investigation and Medical Examination, including Alcohol / Drug screening

Applications must be completed with all required documents and **MUST** be returned
